The fees are adjusted every year according to the cost-of-living index.

These fees do not include : supplies (paintings, pencils, papers, ...) and visits to museums.

ENROLMENT FEES an amount of 600 €, non refundable, is required for the study of each candidate's file. The 600 € fees has to be sent with the candidate's file or paid during the motivation interview.

PAYMENT CONDITIONS

In accordance with the French visa regulations, students must pay one full year's tuition fees prior to receiving the final letter of admission. **If, for any reason whatsoever, a visa is refused, students will receive a full reimbursement of tuition fees** (except enrolment fees).

WELCOMING OF FOREIGN STUDENTS

MOD'ART International reserves a privileged welcome for foreign students. Due to the difficulties often encountered at the time of enrolment (obtaining the student's visa, assistance with accommodation, ...), MOD'ART International helps its students with all the required procedures.

SOCIAL SECURITY

Each student (foreign or French) must be affiliated with the French Social Security (Health Insurance : contribution 2009/10 : 198€). Registration procedures take place at MOD'ART International at the beginning of the school year.

COST OF LIVING MOD'ART International's estimate of the average cost of living of a student in Paris : 850 €/month for accommodation in a student residence, food and transportation. This sum would be much higher in the case of apartment rental.

ADMINISTRATIVE PROCEDURES

Each foreign student has to obtain a "carte de séjour" (residence permit), MOD'ART International helps its students in each stage of the administrative procedures.
